## ROSITA FACES EARLY CHALLENGES

#### Story:

Rosita was born in Mexico, spent time in an orphanage there and was adopted by a couple from Valmeyer at the age of 10. Rosita has a developmental disability, learning disability and always struggled in school. In May of 2000, Rosita graduated from Valmeyer High School. Her parents were worried about what would happen when she graduated high school. Would she have a meaningful life after high school? What would she do?





#### **ROSITA FINDS HSS**

#### Story:

Rosita's parents knew there had to be resources in the community that could help them. The school counselor referred Rosita to HSS. They reached out to HSS and found the support they were looking for. Rosita now had a local organization that was working with her to make a plan for the future .

#### Story:

When getting to know Rosita we discovered that she greatly values her independence. High on her list of dreams was having a place of her own. Rosita lived in HSS housing with a roommate for some time and now has her own apartment. Rosita enjoys riding her bike around Waterloo!



#### **ROSITA GETS A JOB**

#### **Story:**

After Rosita realized she wanted to be a caregiver, the staff at HSS helped her get a job where she could utilize her skills. A job coach worked oneon-one on site at the job with Rosita until she was comfortable enough to be on her own. Rosita now works at a nursing home caring for others and loves what she does!

71 individuals are served by HSS community employment programs






### **ROSITA BRINGS HER DREAMS TO LIFE**

We are proud of the work we do to improve the lives of those who need us, and we know we could not do it without a strong foundation of support.






